s I finish my first several months in office as president, I want to thank Amy Young, MD for her leadership over the last two years and applaud her accomplishments. Specifically, she completed a successful capital campaign, raising \$1,000,000 for our Capstone Programs, including the Academic Scholars and Leaders Program, Surgical Education Scholars Program, and the Martin L. Stone, MD, Faculty Development Seminar. In addition, she strengthened our Electronic Resources Committee, created a searchable database with abstracts from our meetings, and an online Obstetrics and Gynecology supplement highlighting select articles and abstracts from our annual meeting. These are monumental accomplishments that are critical to our mission and membership. Thank you for all your hard work, Amy. Your shoes will be hard to fill.

As I embark on my two years as president, I have developed a slogan for my presidential priorities: "Inclusive, Innovative, and International." I believe this phrase encompasses both my passions and those of our membership. For the inclusive piece, I have appointed Carol Major, MD to lead a Diversity Task Force charged with assuring that our leadership reflects our membership, and that we are welcoming as many people as possible to become involved in our organization.

With innovation, I really want to focus on developing products, particularly technological products, that are accessible and helpful to educators. We are completing a curriculum for learners in low-resource settings that will be accessible on our Web site by the annual meeting in March 2015. Helen Morgan, MD, from the University of Michigan, is developing videos for the APGO Medical Student Educational Objectives that will be available in the fall of 2015. Our Testing and Technology Committee,

led by Maya M. Hammoud, MD, has developed a Knowledge Assessment that can be used by incoming interns for the knowledge component of Milestone 1. Francis S. Nuthlapathy, MD is leading a team that is developing online resources for community educators to improve their teaching effectiveness. We will also continue to upgrade our Web site to make it easy to navigate and user-friendly.

On the international front, we want to make our resources widely available. Open access for our educational modules is now available. We continue to host international scholars at the Martin L. Stone, MD, Faculty Development Seminar. Our March meeting in San Antonio will include plenary speakers on global health, diversity and disparity, with Saturday, March 7th dedicated to breakout sessions on these topics.

We plan to continue our strong collaboration with CREOG, particularly in the area of surgical education and the Milestones, as well as Interprofessional Education. Finally, we want to ensure that we are meeting the needs of our constituents and continuing to grow in a meaningful way. We will embark on a strategic planning process to find the best direction and use of our time in areas of focus for the next five years.

Wow, that is a lot on our plate for the next two years! I look forward to the challenge and want to make sure that we are listening to your priorities. Please let me know your thoughts on our agenda and accomplishments thus far.



- Preparing and publishing an annual Obstetrics and Gynecology Journal Watch in *Teaching in Learning in Medicine* (Journal watch from the Alliance for Clinical Education: Annual Review of Medical Education Articles in Obstetrics and Gynecology, 2012.) Teach Learn Med. 2014;26(2):204-8).
- Ongoing development of several additional "To The Point" series articles which are nearing completion and/or have been submitted for publication, on topics including patient safety, teaching in the operating room, and the electronic medical record.
- Additional activities include ongoing contribution of articles to the APGO e-Bulletin, with a new theme: "Be Involved. Be Connected. Be Inspired."
- Representation on the Alliance for Clinical Education (ACE)
 Executive Committee, with UMEC members on the Publications,
 Communications and Research committees. UMEC also has continued representation on the APGO Electronic Resources
 Committee.

APGO TESTING AND TECHNOLOGY COMMITTEE

During the past year, the committee updated the APGO Residency Directory, created an online Catalog of Abstracts, reviewed online grant funded program materials, and online educational resources for accuracy. In May 2014, the newly revised APGO Residency Directory was launched. This online resource was improved to make the data easier to update by residency programs, and the search function was enhanced to make it easier to find specific information. The newly created APGO Catalog of Abstracts now houses all of the oral and poster abstracts presented from the 2012–2014 CREOG & APGO Annual Meetings.

The APGO Testing and Technology Committee meets each July to review questions from the APGO Undergraduate Web-Based Interactive Self-Evaluation (uWISE) to ensure that they comply with current medical guidelines and recommendations. This year, the Committee also developed an online, interactive self-assessment exam based on Milestone 1 called the Preparation for Residency Knowledge Assessment Tool. The 100-question test addresses topics in obstetrics, office practice and gynecology. The test was launched in January and is now available to all residency programs and schools as part of a uWISE subscription, or can be purchased as a stand-alone subscription. The exam is intended for use by students entering their first year of residency and is a great resource for assessing the knowledge of students participating in an ob-gyn boot camp.

Faculty Development Seminar

The 2014 APGO Martin L Stone, MD, Faculty Development Seminar, "The Path to Wellness: A Medical Education Checkup," was held January 11-14, 2014, at the Eau Palm Beach in Manalapan, Florida. Organized by the APGO Undergraduate Medical Education Committee under the direction of Program Co-Chairs Loraine Dugoff, MD, Archana Pradhan, MD, MPH, and B. Star Hampton, MD, this meeting is intended for physician educators who teach medical students and residents in obstetrics and gynecology and women's health. The seminar is designed to provide both personal and professional development and serve as an opportunity for attendees to network with other like-minded women's health educators. Keynote speakers included, Charles J. Hatem, MD, as the Martin L. Pernoll, MD, Educator, panel discussion with Debra A. DaRosa, PhD, Anna T. Cianciolo, PhD, Martin V. Pusic, MD, MA and Ann E. Burke, MD, Michael R. Foley, MD, and Ryan D. Madanick, MD. The Susan M. Cox, MD and Doug Morris President's breakfast session was delivered by Amy E. Young, MD, and, the Lunchtime Learning Session was presented by Eva Archer-Smith, who discussed work-life balance. Other topics throughout the program included career development, educational scholarship, Milestones, social media and the medical educator. Thirty workshops submitted through the call for abstracts were integrated into the three-day program as small workshop and round table sessions. During the meeting, the 2014 William N.P. Herbert, MD, Promising Educator Award was presented to Lydia Nightingale, MD, of the University of Oklahoma. Each year, attendees come away feeling recharged about medical education, armed with new ideas and approaches to teaching students about women's health.

CREOG & APGO Annual Meeting

The 2014 CREOG & APGO Annual Meeting, Signs of Progress in Women's Health Education, was held February 26 - March 1, 2014, at the Hyatt Regency in Atlanta, Georgia. Sonya S. Erickson, MD and Mark B. Woodland, MA, MD, served as the program co-chairs. The Warren H. Pearse, MD, Lecture titled, "Promoting Excellence in the Clinical Learning Environment," was presented by Diane M. Hartmann, MD. Additional keynote addresses integrated into the three-day program included, "Creating a Continuum of Learning for the 21st Century Physician," by Carol A. Aschenbrener, MD; "The New CME: Rewarding Faculty and Improving Performance

and Outcomes," by Ronald S. Gibbs, MD; and, the Saturday morning session focused on "Milestones Implementation: Opportunities and Challenges." The 2014 meeting format included a special breakfast session for residents and medical students, a Book Club session, a Tech Talk session, and a Fellowship Coordinators afternoon session. Additionally, a Saturday afternoon workshop sponsored by CREOG & APGO on Emerging Technologies covered the fundamentals of a standardized robotic education curriculum.

The APGO UMEC planned several sessions throughout the annual meeting program, including two breakfast sessions: "From Conception to Delivery: Getting Your Education Idea to Publication," and "Team Building: Zoom In Zoom Out: Envisioning Your Education Team." Breakout sessions included, "Professional Identity Formation," "Focus on Solution: EMR in the Medical Student Curriculum" and "Joint Challenges: Areas of Overlap with the LCME and ACGME."

Clerkship Directors' School

The APGO Clerkship Directors' School is designed for clerkship directors of all experience levels and consists of three parts. Parts 101 and 201 of the school are held during the APGO Martin L. Stone, MD, Faculty Development Seminar in January each year, and Part 301 is held during the CREOG & APGO Annual Meeting each year. The 2014 advanced 301 course, "Reading the Signs: Staying Ahead of the Curve on the Ob-Gyn Clerkship," was held during the CREOG & APGO Annual Meeting on February 26, 2014. This half-day program provides an opportunity for clerkship coordinators and directors to meet jointly during a special lunchtime session and cover areas of interest to physicians and their coordinators. The Clerkship Directors' School is also ideal for those faculty who are considering becoming a clerkship director in the near future. All sessions include a combination of short plenary sessions, special focus topics, round table discussions, and small and large group interactive sessions. Each year, UMEC is charged with developing the curriculum for all three parts, ensuring that both the basic foundational elements of the clerkship and new, innovative approaches to the clerkship are covered well. A certificate of completion is issued to attendees who complete all three sections of the school within a three-year period.

APGO INTERNATIONAL SCHOLARSHIP

As part of APGO's commitment to actively engage international ob-gyn educators, the APGO International Scholarship enables international attendees to participate in the APGO Martin L. Stone, MD, Faculty Development Seminar (FDS). A stipend of up to \$5,000 is paid to the sponsoring member department to help defray the awardee's costs associated with this scholarship. NOTABLE APGO EVENTS

Nausea and Vomiting of Pregnancy Module: US and Canadian Information Campaign

Updated in 2013, the "APGO Nausea and Vomiting of Pregnancy" module was created for ob-gyn educators to use when teaching medical students and residents the effect of NVP on the outcome of pregnancies and how to institute appropriate management strategies. In early 2014, APGO launched an information campaign by sending flyers to over 100,000 women's healthcare providers across the US and Canada. Both the information campaign and the development of this module were funded by an unrestricted educational grant from Duchesnay.

Diagnosis and Management of **Endometriosis:** Pathophysiology to **Practice CME Extended**

An extension was granted enabling APGO members and subscribers to earn CMEs for the "APGO Diagnosis and Management of Endometriosis: Pathophysiology to Practice" online educational module through May 2016.

Contraception: Patient Counseling and **Management Module Update**

In 2014, APGO updated the online educational module "Contraception: Patient Counseling and Management." This module reviews the methods of contraception currently available in the US, including the contraindications, risks/ benefits, and non-contraceptive health benefits of each method. Information on counseling patients, as well as the unintended pregnancy rates for birth control methods, are also included. APGO plans to launch the updated companion teaching slides and case studies in the spring of 2015. This module update was sponsored by an unrestricted educational grant from Bayer HealthCare Pharmaceuticals and Afaxys.

APGO Corporate Liaison Council (CLC) Update

APGO leaders and industry partners participated in their annual meeting and networking events in August of 2013 and February 2014. They had one-onone meetings with the APGO Board of Directors and formally reviewed the APGO online educational module for medical students and their faculty titled, "Interactions with Industry: A Medical Student Guide."The updated module is scheduled to launch in the fall of 2014.
